







The legal basis of the data processing is the informed explicit consent given by the consumer during the registration (as per Article 6.1. a) of GDPR). Data necessary for the performance of later transactions are processed based on the performance of a contract by AJKC (as per Article 6.1. b) of GDPR). AJKC processes the personal data only until it is necessary for the purpose stated above.

AJKC keeps the personal data in line with the applicable law ensuring that only employees, or other persons acting on behalf of AJKC (e.g. the Data Processors listed below) have access to the data who need the access in order to perform their job or tasks. The employees with access have signed appropriate Confidentiality Agreements pertaining to the data the come in contact with while fulfilling their duties.
